Mark your calendars for the Fruita 3rd of July Fireworks presented by Canvas Credit Union!

The show will begin at sunset on Wednesday, July 3, 2024, and can be seen from almost anywhere in Fruita. Fireworks are launched at the James M. Robb State Park. Snooks Bottom Open Space will be closed to the public for the entire day of July 3. Please refrain from using personal fireworks as they are a fire hazard and can be disruptive.

Take note of traffic impacts from the show:

- Expect traffic delays around Fruita and please plan accordingly.
- When the traffic closure goes into effect, Highway 340 will be closed going southbound towards the Colorado National Monument. All traffic will be directed Northbound.
- Traffic will be guided towards the I-70 Frontage Road, I-70 Highway, and Aspen Avenue.
- People can expect high traffic volume coming from the James M. Robb State Park entrance, Jurassic Avenue, and Raptor Road.

Irrigation Shutdown Next Week

Starting Monday, July 1, the irrigation line which supplies water to residents south of Ottley Avenue and just east of about Ash Street (following the ditch) to along J.6 Road will be shutdown for about three days for a contractor to connect a new sewer line and realign the irrigation pipe. We are working on getting as much

Weekly FAQ

In every weekly update, we will be answering one question we get asked often from the community. These questions will cover a variety of topics from all city departments. If you have any questions, you think would be valuable for us to share, let us know by emailing communications@fruita.org.

- **Question**: What criteria does the Fruita Community Center use to determine closing the outdoor pool during inclement weather?
- Answer: The Fruita Community Center will close the outdoor pool during a storm if lightening is occurring within 8 miles of the pool. Pool personnel will monitor the situation for thirty minutes and then reevaluate if the storm has passed and it is safe to reopen or if closure is still necessary.

General Updates

- Next Week's City Council Meeting. As a reminder, the City Council meeting scheduled for July 2, 2024 has been canceled due to the 4th of July. The next regular City Council meeting will be on July 16, 2024.
- Colorado Municipal League Conference. Last week, the Mayor, most of the City Council, and staff attended the annual Colorado Municipal League conference in Loveland. Our group attended sessions on workforce housing developments in other communities, economic development, the legislative session recap, new grant opportunities at the state and federal level, and more. Our group also had the opportunity to visit Downtown Loveland and see unique developments there, along with touring parks, and more. This conference is a great opportunity to meet with other organizations and our partners throughout the state, and learn from others.
- **DOLA Grant Presentation.** On Wednesday morning, Mayor Breman, Public Works Director Kimberly Bullen, and I went to Montrose to provide a presentation on our grant application to the Department of Local Affairs (DOLA) Energy Impact Committee for the Greenway Drive Sewer Improvements. We should hear back on the grant application by next month.
- Fruita Fourth Fridays Tonight! The Fruita Fourth Friday is tonight at the Mulberry Plaza from 5:30 8:30 p.m.! Head downtown to enjoy community, art, live music, food, and drink. More information can be found here: Fruita Fourth Friday's Facebook
- Fruita State of the Community Breakfast. On Tuesday morning, most of the City Council, staff and I attended the annual State of the Community Breakfast hosted by the Fruita Area Chamber of Commerce. We heard from our local, regional, state, and federal representatives. The speakers discussed Fruita and Mesa County updates, a recap of the legislative session, and what

is going on at the federal level. Mayor Breman did a great job providing the Fruita update, and discussing our current accomplishments, but also our goals and priorities for the next several years.  on Friday and are being evaluated. The new ramp will be at the north end of the building and
 will serve as ADA access during festivals that close the ADA ramp at the south end of the
 building.
- 19 Road Construction Communication Mailer. Another mailer will be sent out early next week to communicate to residents about the upcoming 19 Road Construction Project. The mailer has information about the project and the best ways to stay updated on the project, including information on the two upcoming informational meetings.

PROJECT OVERVIEW - This project will include sanitary sewer and storm drain installation from the canal north to J.2 Rd., Irrigation line and structure improvements at J Rd. and J.2 Rd., including the replacement of the line along the west edge of 19 Rd. from J Rd. south to Iron Drive, Road widening, Pedestrian path installation.

The recommended detour route is from J Road and using 20 Road. Please visit fruita.org/19road for more project information, frequently asked questions, District 51 school traffic routes, and project updates. We appreciate your patience while we make improvements.

Parks and Recreation

- Reed Park Update. The Northern Pavilion landscaping is in process and irrigation work has begun around the shelter. The electrical pedestals have been installed in the park, and the electrician is waiting for the transformer before the electrical is operational for the Farmer's Market. We will continue to provide a generator and spider boxes until the site electrical is completed. The wheel park continues to progress, the deep bowl has finishing touches being completed this week with tile and pool coping being installed. The last concrete pour is scheduled for July 1st. They will then focus on final cleanup, installation of rails, and walkthrough with the wheel park designer scheduled on July 18th. The remaining flatwork in the park and asphalt is scheduled to be completed the week of July 8th through the 12th.
- Wheel Park Notice. We want to remind everyone that construction is still in PROGRESS! The wheel park is not open to the public, and the contractor is still working on the finishing touches.
- **Community Center Waterslide Update.** The contractor has started forming the spread foundations for the support of the waterslide. They will complete the forms this week and schedule inspections next week with concrete scheduled after inspections. We are still on schedule for a September installation.
- **Parks Update**. The parks crew is working on tree protection at Snooks Bottom. There has been a beaver causing damage and falling young trees, we are trying to preserve the current tree canopy by installing and ensuring there is tree protection around the trunk. Crews have been

aerating and fertilizing parks. They are also preparing Little Salt Wash for overseeding and topdressing.

Public Works

- Congratulations Troy and Jim! Troy Melroy completed the Pipeline Assessment Certification
 Program. He also successfully completed Lateral Assessment Certification Program and
 Manhole Assessment Certification Program. These are certifications that follow national
 standards for infrastructure inspection. Congratulations to Jim Batchelor for successfully
 completing their Traffic Control Technician certification.
- Road Maintenance Update. Streets crew completed asphalt patching on Carolina St., completed inlay thermal plastics crosswalk at Plum St. And Aspen Ave. Intersection, replaced stop sign at Vista Valley Dr. & Ottley Ave., filled sink hole in the parking lot at S. Peach St. & E. Aspen Ave. Staff completed 171 locates to date for the month of June and overlay paving has begun.
- **Utilities Update.** Utilities staff built and installed a new irrigation headgate cleaner on Carolina Ave. Public Works staff met with SGM Engineering and USFS at Fruita Reservoir #2 to identify pipeline and structure locations as part of the design to breach Reservoir #2.

Wastewater Reclamation Facility Update. Wastewater Reclamation Facility staff is completing
accelerated WET and ERA QA/QC testing at the plant. Staff completed UV semi-annual
maintenance on the UV system and other regular maintenance items.
